

MEMORANDUM

on cooperation between
Association for Farmers Rights Defense, AFRD
and
LIMITED LIABILITY PARTNERSHIP
"SCIENTIFIC PUBLICATIONS"

Association for Farmers Rights Defense, AFRD, represented by the President Der. Kakha Nadiradze, acting on the basis of the Charter, and the **Limited Liability Company "SCIENTIFIC PUBLICATIONS"**, represented by the Pomin Alina, acting based on the Charter (hereinafter referred to as the "Parties"), seeking to develop cooperation in research and scientific and educational activities, in the field of scientometrics and science, based on the belief that cooperation in the field of education and research will contribute to increasing the number and quality of scientific works, their publication in international scientometric databases, have agreed as follows:

Article 1

The Parties will cooperate in the field of education, science, scientometrics and research, adhering to the principles of parity and mutual benefit following the current legislation of the Georgia.

Article 2

The parties will develop cooperation in education, science, scientometrics and research in the following areas:

- cooperation in education, science, scientometrics and research;
- information and organisation support for events held by the Parties, support in preparation and participation;
- information and consulting cooperation on the creation (writing) of scientific papers and articles and their publication in international scientometric databases;

Article 3

Cooperation between the Parties in the fields of education, science, scientometrics and research will be carried out by:

- exchange of information on research projects;
- joint organisation and holding of scientific seminars, conferences and webinars;
- exchange of information and scientific documents;
- organisation of scientific training and courses that will be of mutual interest;
- establishing websites, projects, research centres, etc.

Article 4

The parties will facilitate general direct communication. To achieve this goal, the Parties will exchange contacts of their representatives (delegates) to identify and further develop cooperation areas.

Article 5

Amendments and additions to this Memorandum shall be made by mutual written consent of the Parties and shall be documented, which shall be an integral part of this Agreement.

Article 6

All disputes regarding the interpretation or application of the provisions of this Agreement shall be resolved through consultations and negotiations between the Parties.

Article 7

The Memorandum shall enter into force on the date of its signing and will be valid for three years from the date of its signing by the Parties.

The term of the Memorandum shall be automatically extended unless one Party notifies the other Party of intention to terminate the Memorandum within thirty (30) calendar days.

Each Party may terminate the Memorandum at any time by providing thirty (30) calendar days written notice to the other Party.

This Memorandum defines the areas of cooperation and does not create any legal or financial consequences for the Parties.

This Memorandum was signed on 08.08.2024

Miscellaneous

The Parties separately stipulate that the conclusion of this Memorandum does not bind the Parties to any legal obligations, does not entail the emergence of financial obligations, and that the emergence of the latter requires the conclusion of separate agreements by the Parties.

This Memorandum is not a preliminary contract and cannot serve as a basis for the liability of the Parties for failure to comply with its provisions (none of the Parties will be obliged to compensate the other Party, including (without limitation) damages, losses incurred by the Party in connection with the performance (non-performance), expiration or termination of this Memorandum). With respect to this Memorandum, neither Party shall be encumbered by the obligations or debts of the other Party or Parties, and neither Party shall act as an agent of the other Party or Parties without entering into appropriate separate agreements.

Each Party will bear its own costs arising from the performance of the terms of this Memorandum, except as otherwise provided under the relevant agreements, any information provided by the Parties to each other in writing or orally may not be transferred or disclosed to third parties without the written consent of the Party providing the information.
